#### The Hungarian Revolution of October 1956.

#### Why did the Soviet Union invade?

#### **Background Information**

After Stalin died in 1953 people behind the Iron Curtain hoped for greater freedom. In Hungary in 1956 Moscow allowed Nagy to replace Gero as prime minister. Yet a few days later, a large number of Soviet tanks attacked Budapest, the capital of Hungary. In the fierce fighting which took place, thousands of Hungarians and thousands of Soviet soldiers were killed. Europe had not seen such fighting since the Second World War. Why did the Soviet Union invade?

At the same time as events in Hungary became violent, the eyes of the world turned to the Middle East where Britain, France and Israel invaded Egypt.
