# Introduction

In 2020, the covid-19 pandemic led to many changes to education in England. Schools closed to almost all students from the 20<sup>th</sup> March 2020, and the government cancelled most assessments including GCSEs, A levels and many vocational qualifications. The interruptions to schooling and assessment continued during the 2020-21 and 2021-22 academic years. During this time, the Department for Education have carried out numerous consultations about the approaches to assessment and awarding of qualifications during this time. Due to the ever-changing nature of the pandemic, the decisions that were made following an individual consultation does not necessarily reflect the final method for awarding a qualification in that academic year. For example, exams were originally intended to go ahead in the summer of 2021, with several adaptations, but were cancelled following the January 2021 lockdown and school closures. This document lists the consultations that have occurred during this time and provides basic details about their content. It is split into two sections: one for academic qualifications (GCSEs, A levels, the Extended Project, and the Advanced Extension Award in maths), and another for vocational and technical qualifications. Within each of these sections, the consultations are placed into tables according to the academic year that they applied to.
